

Privacy Policy & SMS Terms and Conditions

ARC Construction Group (“Company,” “we,” “us,” or “our”) respects your privacy. This Privacy Policy explains how we collect, use, protect, and handle personal information, including conversational SMS/text messaging, used solely for project updates, inquiries, follow-up, and service-related information.

1. Information We Collect

a. Information You Provide

We may collect personal information when you:

- Provide your name, phone number, email, or project details via SMS, website forms, or other communication channels.
- Request updates, service information, or follow-up regarding construction projects.

b. Information Automatically Collected

We may collect technical information when you visit our website, such as your IP address, browser type, device information, and usage patterns. This data helps us improve our services and website functionality.

2. How We Use Your Information

We use the information you provide for the following purposes:

- Responding to inquiries and project-related questions.
- Sending updates on project status, service reminders, or follow-ups.
- Improving our services and communication channels.
- Ensuring the security and functionality of our website.

We do not use your personal information for marketing unless you explicitly opt in.

 6. **Privacy:** We do not sell, rent, or share your mobile information with third parties or affiliates for marketing or promotional purposes. All categories outlined in this Privacy Policy exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.
